

## Ludington Area Charterboat Association Net Alert

July 14, 2011 (replaces all previous net alerts)

All nets between Little Point Sauble and Big Point are marked with 5 staffs, each 5' high (no jugs).

The Inside staff has orange over black flags.

All others are marked with only an orange flag. In every case the King anchor staff is the most westerly.

The flags are 14" square and will show on most radars.

Nets are listed from South to North.

It has been confirmed that there are currently no LRBOI nets south of net #1 or north of net #11 in LRBOI Treaty waters.

**Caution:** Additional nets may be placed or currently listed nets may be moved without warning.

Only the pot staff location is known at this time for nets 2 & 3. Additional information will be added when/if it can be learned. All nets stand 30' up from the bottom. Please exercise care in the vicinity of the flags/buoys at all net locations.

When reporting a net incident, be sure to give complete Lat-Lon information, including both north and west numbers in degrees, with minutes in decimal format. Please include the depth if possible, also.**

**This is extremely important for the MDNR record keeping and helps to lead to corrective actions. Anyone observing any length of yellow polypropylene line floating loose at or just below the surface in the vicinity of a net location is urged to promptly report the exact GPS location including the depth, to the DNR RAP (800-292-7800) line as soon as possible.**
